HAVE AGREED to collaborate in International Internship Program 2023. The Internship Program was conducted at Sekolah Indonesia Singapura (SIS) located at 20A Siglap Rd, Singapore 455895.

I. AIM

The program aims to enhance the lecturer and students' insight into the teaching and learning activities at SIS.

II. PROGRAMS

- a. The Faculty of Mathematics and Natural Sciences Students are conducting teaching and learning practise at SIS as the implementation of International Internship Program.
